## WHAT IS THE GLOBAL DATA PROTECTION REGULATION (GDPR)?

GDPR represents a sweeping change in global consumer privacy, governing the use of personal data for over 500 million EU residents. Any company, regardless of their location, who markets and sells to customers or prospects in Europe will now face strict regulations surrounding the use and storage of consumer data. *Fines for non-compliance can reach up to 20 million Euros or 4% of your company's annual turnover, whichever is larger.*

GDPR compliance involves numerous factors but pivots around three key building blocks: consent management, data protection and data quality. GDPR Article 5 specifically address the third building block, data quality and ushers in new standards by stipulating that contact information should be accurate, up-to-date, and corrected without delay.

Article 5 of the GDPR stipulates that information should be *"accurate and, where necessary, kept up-to-date; every reasonable step must be taken to ensure that personal data that are inaccurate, having regard to the purposes for which they are processed, are erased or rectified without delay"*.
